- 1. Call to Order:** Meeting was called to order by Dakota Weldon at 6:33 in the HS Media Center.

- 2. Minutes From Last Meeting:** Changes need to be made to March's minutes including: location changed to Band Room instead of JPAC and Patty had the Hobby Lobby receipt rather than Heather. Heather made a motion to accept the minutes after the changes were made and Leslie seconded. Motion passed.
- 3. Correspondence:**

 - i. Cody made a motion to pay this and Josh seconded it. Motion passed.
 - c. 3 scholarship forms have been turned in. Those are due this week.

- 4. Financial Report:**
 - a. Savings account balance is \$500 set aside for scholarships.
 - b. Checking account balance is \$18,633.21
 - c. \$237.92 was debited to reimburse those mentioned on March's minutes.
 - d. \$263 was paid out for the instrumentalist awards
 - e. \$26.99 was paid to Palmers Hardware
 - f. Josh made a motion to accept the financial report and Cheryl seconded. Motion passed.
- 5. Band Director Report:**
 - a. HS Concert has been changed to May 8th at 6:30 in the JPAC
 - i. 8th grade will be joining the symphonic band for one song
 - b. MS Concert is May 4th at 6:30 in the JPAC
 - c. We need someone to pass out the purple polos at these concerts and at the Memorial Day parade
 - d. 8th graders will be joining the 9th-12th grade band for the Memorial Day parade.
 - e. The majority of the 8th graders will be coming up into marching/symphonic band next year.
 - i. 9 seniors are leaving and 16 8th graders are coming up
- 6. Committees:**
 - a. **Fundraising:**
 - i. We will be selling Buccilli's cards again this year
 - ii. May 27th will be the Carrow's Hotdog fundraiser
 1. 10-3 will be the timeframe and we will need workers to help with this
 - a. Cody will grill
 - b. Preferably we will have students with their horns playing some tunes to draw people in.
 - iii. Bear Claw bags will be sold this fall right when we get back to school
 - iv. ABC Fundraising
 1. We will be selling cookie dough around Christmas time
 - v. Cheryl will check with another school to see how their mum fundraisers work
 - b. **Equipment/Trailer:**
 - i. Paul, Don, and Dakota will make one more trip to Milan to look at trailers
 - ii. Insurance on the trailer is covered through the school

 - iii. Robotics club will probably buy the old trailer

 - c. **Uniforms:**
 - i. Will be collected right after the spring concerts

 - i. August 7-11 at the Springs
 - ii. Price is the same as last year
 - iii. Weekly rehearsals will stay on Monday nights at the football field
 - iv. Earlybird payment deadline is the end of April
 - v. About \$3000 is spent to cover the cost of instructors and chaperones.
 - c. Scholarship forms are due the first week of April and will be reviewed and approved at May's meeting
 - i. Cameron Brown, Jacob Dickenson, and Emilee Wyatt have all turned in scholarship forms
 - d. By-Laws:
 - i. Change the meetings to the first Mondays at 6:30
 - ii. Remove the last sentence under "Membership"
 - iii. Remove the telephone tree committee
 - iv. Remove the membership committee
 - v. Remove bullet 8 under "President"
 - vi. "Secretary" section bullet 11 > By-Laws are kept on the band website
 - vii. Remove "end of year" under the Banquet Committee
 - viii. Remove the Nomination Committee
 - ix. Under the Concession Committee, bullet 7, remove "only adults shall handle the money"
 - x. These revisions will be reviewed and approved at next month's meeting.
 - e. Marching season this fall - the theme for the show will be discussed at May's meeting.

8. New Business:

- a. Nominations for next year's booster officers are coming up.
 - i. Officers currently needed for next year are Vice President and Secretary
 - ii. Nominations will be slated in May and voted on in June
